I am directed to state that the Executive Committee of the Council of Architecture (COA) at its 201st Meeting held on 05.04.2019, considered the assessment report of the Inspection Committee that visited your Institution on 25.03.2019, duly scrutinised by the Scrutiny Committee of Experts (copy enclosed), together with the information provided by institution, for extension of approval of **Master of Architecture (Executive) degree course**.

The Executive Committee has decided to grant extension of approval to **Master of Architecture (Executive) degree course** at your institution as under:

DETAILS OF THE COURSE	INTAKE	PERIOD OF APPROVAL
3-year Master of Architecture (Executive)	20	2019-2020

The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as **Annexure-A**. The approval accorded to your institution shall be subject to appointment of adequate Faculty of Architecture at your institution as per Council Norms, prior to commencement of academic session 2019-2020. The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The Council shall be at liberty to inspect the Institution at any point of time to assess the Minimum Standards of Architectural Education prescribed by the Council and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time. In case the institution is found to be imparting deficient education during 2019-2020, the appropriate action shall be initiated against it.

Further, the Executive Committee decided that the Institutions imparting Master of Architecture degree course in Executive mode be advised to apply for conversion of the said course to full-time regular mode from the next academic session i.e. 2020-2021.
