

Relaxations for Residential Facilities (Academic Session 2021-22)

To facilitate allotment of residential facilities (residence mess, laundry, gym, sports and parking facility) provided by LPU on the campus, the following relaxations are being offered for session 2021-22:

- Proportionate reduction in charges due to late joining of physical classes
- Allotment of residential facilities and adjustment/refund of residence charges

1.1 PROPORTIONATE REDUCTION IN CHARGES DUE TO LATE JOINING OF PHYSICAL CLASSES

Residential facilities in LPU are provided for the full regular academic session which starts in the month of August and continue for about 10 months. However, this year (session 2021-22), because of COVID-19, joining of physical classes (face to face by being present in the University) for majority of students has got delayed resulting in shorter duration of stay in residence and use of other residential facilities.

To address these concerns, the charges of residential facilities are being reduced proportionately. The applicable charges for residence (and related services) for a student will depend on the date of joining the physical classes (face to face by being present in the university) as per the following table:

Joining the Physical classes in the month of -	Charges to be paid for Residential facilities i.e. Residence, Mess, Laundry, GYM, Sports and Parking (in percentage of charges for Academic session)
September	90%
October	80%
November	70%
December	60%

EXAMPLE: The charges for 4-seater standard room (Non-AC) are USD 1150 and for standard mess are USD 650 for the full academic session. In case a student opts for 4-seater standard room and standard mess facility and join the physical classes (face to face by being present in the university) in the month September then the net effective charges after proportionate reduction in charges will be as per the following table:

	Residence Facility	Mess Facility
Prescribed Charges	USD 1150 / INR 78000	USD 650 / INR 38000
Proportionate reduction in charges if student joins the classes physically in September (10%)	USD 115 / INR 7800	USD 65 / INR 3800
Effective Charges to be paid	USD 1035 / INR 70200	USD 585 / INR 34200

1.2 ALLOTMENT OF RESIDENTIAL FACILITIES AND ADJUSTMENT/REFUND OF RESIDENCE CHARGES

Student can book the residence and mess facility with initial deposit of USD 500/ INR 20,000. However, student must deposit the balance/pending charges by the prescribed date before joining / reporting the university residence.

- If student initially book the residence facility but later on, because of COVID-19, is not able to join the same then the amount already deposited will be refunded as per the international refund policy.
- If because of government guidelines, residence facilities have to be closed within the academic session, then the amount already deposited by the student will be refunded after deducting charges for the months for which residence facilities were operational.
- All the students who have booked the university residence and are going to join the physical classes will be assigned a joining date. The residence allotted to a student will be kept reserved for maximum of 15 days after the assigned joining date. If student does not report within 15 days of assigned joining date, the residence seat will be allocated to the next wait listed candidate. In such cases, student may book the residence facility again from the available seats at that time or later on as and when join the University for Physical Classes.

The exact date of joining of classes in physical mode for a specific student / cohort will be communicated separately and will depend on vaccination status and other government as well as University guidelines issued from time to time.

The relaxations mentioned above are one-time special relaxations and cannot be used as precedence.
