

INFORMATION RELATED TO APPLICATION PROCESS

Eligibility Criteria

1. Applicants in their own interest must read and understand all the information published in this International Booklet 2026, Prospectus 2026, the university website www.lpu.in (under the head international Admission i.e. https://www.lpu.in/international/downloads/general_admission_guidelines.pdf), and otherwise published by the University from time to time.
2. The International Booklet 2026 is provided free of cost and can be procured on request from the Admission office at the University Campus, Phagwara (Punjab, India) or from the designated camp offices/representative office of the University or such other places as specified by the University or can be downloaded from the university website (under the head International Admission

3. The eligibility criteria for most of the programmes published in International Booklet 2026 for international applicants is Pass with 50% marks in the qualifying examination and having studied such courses as prescribed by this University on its website www.lpu.in/international (under the head International Admission i.e. <https://www.lpu.in/international/programmes/ProgramSearch.php>)
4. For programmes not published in International Booklet 2026 but specified on the university website www.lpu.in/international (under the head International Admission i.e. <https://www.lpu.in/international/programmes/ProgramSearch.php>)
5. For Admission to Ph.D. programme (except Agriculture), the minimum eligibility criteria for international student are Master's degree in the relevant discipline with 55% marks and fulfilment of any other eligibility criteria prescribed by the University.
6. For Admission to Ph.D. programme (Agriculture), the minimum eligibility criteria for international student are Master's degree in the relevant discipline with 65% marks and fulfilment of any other eligibility criteria prescribed by the University.
7. Issue of offer letter (conditional or unconditional) or any information or guidance or facilitate on given by the university should not be construed as confirmation of admission or access to any facility of university.
8. The university reserves the right to add, withdraw or change at any time, without any notice, information contained herein or otherwise published or announced by the university as well as any provision or facility as and if deemed necessary, No responsibility will be accepted by the university for hardship or expenses incurred by the applicant or any person(s) on this account, no matter how they are caused.
9. In case of any dispute or any matter concerning the university, whether covered herein or not, or interpretation of any content herein, the decision of competent authority of the university shall be final and binding on all concerned and the after the courts at Kapurthala (Punjab, India) only shall have jurisdiction for unsolved disputes.

10. For the purpose of equivalency of the qualifying exam, the qualifications as recognized by AIU are considered. For qualification not recognized by AIU, equivalency proof has to be provided by the applicant from the Indian High Commission/ Consulate in their respective country or other concerned statutory body as applicable.

Note: Eligibility for Programme B.Arch; B.Pharm; B.A., LL.B. (Hons.); B.B.A.LL.B. (Hons.); LL.B.; LL.M.; D.P.Ed.; B.Ed.; B.P.E d. and M.P.Ed. will be same as for Indian Applicants.

ioEnglish Language requirement for International Students:

1. All International Applicants are required to satisfy one of the following English Requirements irrespective of the Programme in which they are seeking admissions i.e. if an applicant is seeking admission in a programme where English is not prescribed as compulsory course in the Eligibility condition; even then he/she has to satisfy one of the following English Language requirements.
 - ✓ Applicant must have passed English course in 10th or higher examination. OR
 - ✓ Applicants has done his/her education (eligibility qualification or higher) in some university/school where English has been the instruction of language. In such cases, applicant has to provide a proof of the same from the University/School or have to provide a document that is available on the official website of the University/school. OR
 - ✓ In case applicants who do not fall in any of the above category then he/she will have to provide one of the following proof of English language Proficiency
 - IELTS BAND of 5.5
 - TOEFL (ICBT) score of 70 or equivalent in any of the TOEFL format
 - Certificate for Proficiency in English Language with minimum duration of 3 months
2. All the international students should be proficient in English Language. It is recommended that only applicants who have strong reading, writing, speaking and understanding of English Language should apply. University will not be responsible for any problem faced by student in class because of poor English Language proficiency of the student. No relaxation in the exam or any other component of evaluation of the university will be provided in such cases. In case the University apprise that the student is not proficient in English, the student might be asked to join English Language Program concurrently with the regular program. The University can also change his enrolled program and put him in any other program deemed appropriate for him by the University.
3. If the degree/transcript or certificate of a candidate does not clearly specify the grade or percentage obtained by student in the qualifying exam then *to find equivalent percentage from a given transcript/DMC, the method as prescribed in Prospectus Part – C under the head “General Admissions Guidelines” shall be used.*
